



## REGULATIONS ON FAIR PARTICIPATION

- A.** Exhibitors and sub-exhibitors, called generally hereinafter The Exhibitors, are obliged to observe the conditions and/or the regulations presented in the Contract. Any changes have to be made in writing and signed by an authorised representative of the MTK International Katowice Fair, Ltd. (called hereinafter The Organiser) and an authorised representative of The Exhibitor.
- B.** Filling and signing the 'Participation Application Contract', placed overleaf, and submitting it to The Organiser is a condition The Exhibitor may participate in the Fair. Persons signing the 'Participation Application Contract' declare simultaneously thereby that they are duly authorised to represent their company.
- C.** The Organiser commits himself to place the Building Regulation and fire regulations in a fairly visible place. The Exhibitors are obliged to make acquaintance with the regulations and strictly observe the instructions and requirements contained therein.
- D.** The Exhibitor rights, especially the right to take an Exhibition surface on lease, must not be transferred to any third company nor person unless an appropriate consent has been given by The Organiser and respective charges have been collected by The Organiser. The Exhibitor bears full responsibility for any activities of his co-exhibitors, including observation of regulations valid during the Fair event in particular.
- E.** Companies providing fair stand construction services at the MTK site are allowed to render their construction services only upon purchase of a licence of the object owner, i.e. MTK. Licence costs is € 4.50 per sq. m of a developed area in pavilion and on the outdoor area.
- F.** The Exhibitor has a right to exhibit and/or publicise his goods only at his purchased stand provided his exhibits do not cover up neighbouring stands/exhibits nor disturb regular operation of other exhibitors. Using any sound amplification equipment, additional unauthorised illumination, etc., that can cause a disturbance to normal operation at other Exhibition stands is forbidden.
- G.** The Exhibitor is not allowed to organise any promotion action outside his stand without consent of The Organiser. Setting advertisements outside the stand is charged extra.
- H.** The Exhibitor is obliged to stay at his stand during the Exhibition opening time, and while entering/leaving the Exhibition hall to use the identity card provided by the Organiser. 1 id card per each 6 sq.m space.
- I.** The Exhibitor is not allowed to dismantle his stand and/or remove his exhibits while the Exhibition continues, i.e. before the fixed time the Exhibition is officially closed. During the whole time the Exhibition continues, as well as during erection/dismantling of the Exhibition stand, an authorised representative of the Exhibitor has to be present at the site. Detailed information on principles of the Exhibitor stay at the Exhibition site before its opening, during the Exhibition and/or after its closing shall be submitted to the Exhibitor in a separate notice.
- J.** The Organiser and his representatives do not bear any responsibility for any accident and/or injury, neither for any loss, theft and/or damage to property of The Exhibitors and/or his guests whatsoever that occur as a result of any cause, except damage resulted from a failure of The Organiser. The Organiser provides protection of property in time the Exhibition hall is closed. The Exhibitors are reminded of necessity to insure appropriately their exhibits and equipment they are responsible for, including their private property. Should any hazard, accident and/or damage occur The Exhibitor is obliged to inform immediately The Organiser. The Exhibitor is obliged to observe all instructions regarding the protection provided by The Organiser and/or his representatives. Any claim for damages of The Exhibitor have to be submitted to The Organiser in writing during the Fair. In case of any damage in property of The Organiser and/or the Fair area owner resulting from improper use of the exhibition stand The Exhibitor has to indemnify them for losses suffered.
- K.** The Organiser and/or his employees do not bear any responsibility for any errors and/or omissions related to teleaddressing, informative, and/or bank data whatsoever that are included in materials elaborated and provided by The Exhibitor and/or Advertiser. It refers to the CATALOGUE ENTRY, which is obligatory for all exhibitors.
- L.** Signing the Contract and submitting it to MTK International Katowice Fair, Ltd. is equivalent to the Exhibitor undertakes an obligation to pay all amounts as stipulated in the Contract. The Contract may not be cancelled by The Exhibitor. The Exhibitor acknowledges hereby to be not entitled to claim for reimbursement of any sums already paid off in relation of the Exhibition because MTK International Katowice Fair Ltd., due to concluding the Contract, has borne related costs and is therefore entitled to demand payment of all amounts resulting from signing the Contract.
- M.** The Organiser and/or his employees do not bear any responsibility for any loss, damage nor delay caused by force majeure, social unrest, operation of State and/or Local Authorities, strikes and/or other circumstances being beyond the Organiser control that prevent or entail renouncement of The Organiser to organise the Exhibition in planned time and/or place. The Organiser reserves a right to change time and/or place of The Exhibition in case circumstances being beyond his control compel him to do so. Should such circumstances occur The Organiser shall inform The Exhibitor immediately about causes and resulting changes. The Organiser is not responsible for and is protected against any claim related to any conflict and/or dispute with the Local Authorities where The Exhibition takes place and/or other bodies whatsoever in respect of any aspects of The Exhibition, that could affect unfavourably The Exhibitors. The Exhibitor acknowledges that The Organiser also suffered damage and loss in result of the above and therefore The Exhibitor declares hereby his resignation from any claims for damages. Amounts paid to The Organiser as appropriate charges, etc., in relation to The Exhibition, remain possession of The Organiser.
- N.** The Organiser is not obliged to assist The Exhibitor to obtain respective documents enabling The Exhibitor to enter Poland. The fact that The Exhibitor has not obtained the documents allowing him to enter Poland is not a reason to annul this Contract and to claim reimbursement of the sums already paid off. However, The Exhibitor may appoint other party/company that is able to enter the Country The Exhibition is to take place, to represent him. Such a replacement is to be performed on The Exhibitor's (i.e. the party that has concluded The Contract) own exclusive responsibility.
- O.** The Organiser is not responsible for any loss, damage and/or delay caused by/related with shipment of the consignment (transport, handling and/or custom clearance) to/from the Country where The Exhibition takes place. The Exhibitors are recommended that all their consignments should be appropriately insured.
- P.** The Exhibitor explicitly reconfirms that never have been made any statement – neither tangibly nor as a hint – about contracting possibilities (potential of business) thanks to participation in The Exhibition, about possible business successes thereof, etc., nor that The Organiser and/or any of its subsidiaries and/or agencies, his employees and/or other legal entities/parties somehow associated with, have provided any guarantees and/or assurances in relation to The Exhibition. Moreover, The Exhibitor reconfirms that this document is the whole of principles regulating co-operation between The Parties, and that The Exhibitor has not received any changes/modifications to this document.
- Q.** This Contract is governed by provisions of the Law of Poland and construed accordingly. Any disputes between The Parties arising from or in connection with this Contract are to be settled by the court of factual jurisdiction in Katowice, Poland.
